



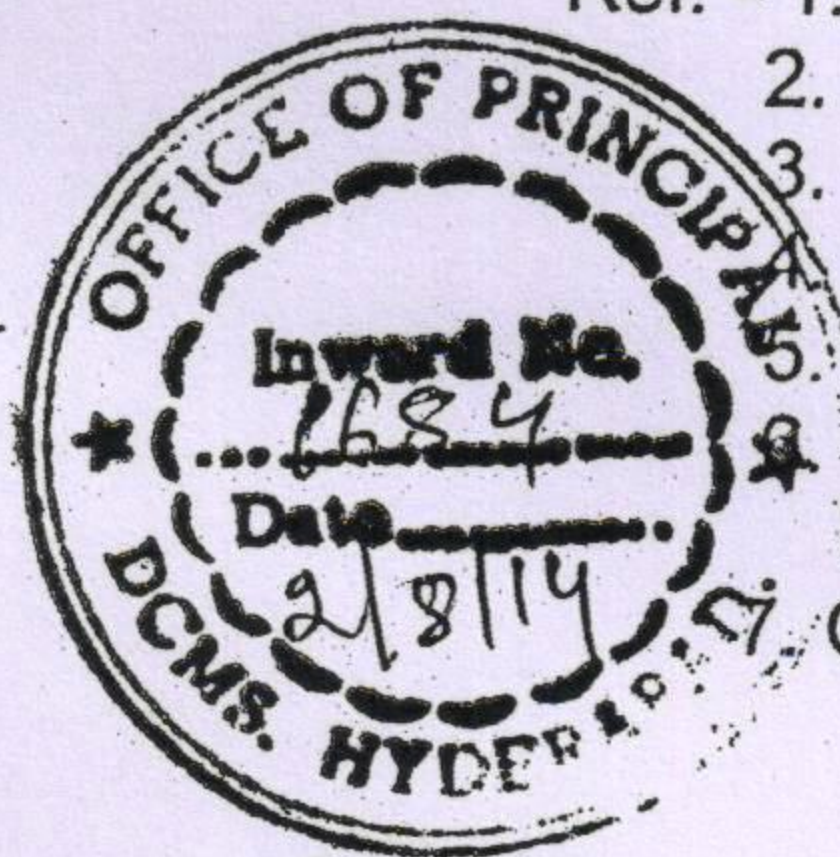

The Admissions shall be made under the rules prescribed by the Govt. vide G.Os. in the reference 1<sup>st</sup> to 5<sup>th</sup> cited.
